Statement of Service Performance

North East Valley Community Development Project Incorporated For the year ended 31 March 2023

Outcomes that the Valley Project is seeking to achieve

The Valley Project aims to create an inclusive, connected and thriving community, and to mobilize the community through the community's strengths and locally led action. The Society intends to build strong community ties and improve the well being of local families in the greater North East Valley area.

The current initiatives developed by the Valley Project include:

- Kai Share, weekly kai parcels of rescued food, via Kiwi Harvest for local families for short term need,
- The Valley Voice, local community newspaper distributed locally and readership of over 10,000
- Valley Kai, increasing food security regionally and locally through locally led incentives destablishment of a dry food co-op. Also the establishment of Kai Pantries around the community.
- Maintaining a Community Hub for Community Groups
- Subsidise Valley Counseling Service to a reduced rate for those in need.
- Open VUE, Open Valley Urban Ecosanctuary with a focus on local bio versity and participatory science within our schools. Also has a focus on restoration of the creek.
- Good Sort AllSort Award, celebration of the best in our awesome community through social inclusion.
- Walley Community Workspace, Landlord to a hub of low arbon technologies and innovation.
- Umbrella a multitude of smaller community groups, e NEV mmunty Gardens, Dalmore Community Gardens, Transition Valley 473, Great Kiwi Poster Competition, Otago Military History Great.
- M The Project Business Directory free space for business and groups to sign up and be connected together in one space.

Output Measures

Kai Share

Led by two volunteers, and there provide short term support for locals. Kai Share provides 35 kai bags for local families weekly. It has just celebrated it, 2th by holds as part of the Projects family.

In the 2022/23 financial year, Kai hare has received 15,079kg of donated kai from our main provider, KiwiHarvest. That's an average of around 43,000 has

Currently there are 35 families who are in the Kai Share whanau, there has been a review and a reset of the program which has seen eligibility change, given room to grow to 50 Kai parcels and also the introduction of a Pine Hill Kai Share program within the Pine Hill Community to recognise the need as a result of the recession and cost of living.

Part of the Kiwiharvest family it has utilized the rescued food from supermarkets, and through other sources to be entitled to the best produce available.

Kai Share has been future proofed for the next 10 years.

The Valley Voice

The Valley Voice goes to over 4,000 households every month Project surrounding suburbs, with an additional 400 digital subscriptions and growing. The primary goal behind the newspaper is to keep the community informed, connected, involved and socially connected with each other. It's a powerful tool for community led development. It's also a chance for the Project to advertise local business and celebrate all things local. The Valley Voice is now in its 40th year.

Valley Kai

A food resilience/security project that puts food security at the heart of what we do. Many initiatives have been umbrellaed under the Valley Kai such as two Kai Pantries, multiple workshops, christmas food parcels to the community, community-wide fruit harvest and pressing, preserving workshops, seed sharing/saving, close liaison with the community gardens. There is room to establish a dry foods co-opt with the local community and food distribution partners across the city. We also partnered with T&G to regularly receive over 1T of export quality fruit to be redistributed within our community.

Community Bumping Hub

Over 35 groups per week use our community hub. It includes exercise, art and music groups, knitting, yoga, community classrooms, legal advice, JP services and many more which benefit the community.

Spring Clean

The Waste minimisation event is a series of workshops and events held by local organisations of vering to lice such as reusable pad making, waste reduction and recycling, weed identification, community clothes swap, and waste minimizing products at a market. Over 350 people attended the event throughout the day. The event continues to row year on year and be very popular.

Valley Counselling

The Valley Project subsidise VC to provide mental health support at a reduced ate for it imbers our community. Over 400 hours a year in support and is widely used, has seen a 76% increase in grow or service in a set year with additional days being added to keep up with demand. This service has been going since 2020 and a growing year on year.

Open VUE

Over 600 volunteer hours since Jan 2022! Trapping in collaboration with the Project and has seen over 50,000 pests trapped regionwide. The development of a 100 year to Lindsay Creek Restoration Project. Has had over 350 plants planted in Chingford Park restoration with a key group of colunteers. Growing locally seeds and seedlings at the Propagation Nursery. Involvement with various community events and estivals around the city with other environ groups. CreekFest attended by 300 people and had a market was a success of participatory science but also community collaboration and connection. First event since COVID-19.

Valley Community Workspace

Good Sort Allsort Award

A social inclusion program aimed to celebrate the best of our community, highlighting and celebrating the good in our community. It is a charge for the community to say thanks to those who have been real Good Sorts in the community. Seen as a way to combat the negative and mis-information as remnants of COVID-19 in the community, will be seen as something that keeps the community positive and connected.

Umbrella Organisations

The Valley Project provides financial and administrative services to several small community/ nationally led groups, who benefit from our charitable status, allowing for community led empowerment.

Volunteers

There are approximately around **3600 Volunteer** hours put into the community and the Project's causes. The Executive Committee of the project with its 6 members contributes the equivalent of 5 full FTE workers to the Project free of charge.

Statement of Accounting Policies

North East Valley Community Development Project Incorporated For the year ended 31 March 2023

Basis of Preparation

As the Society is a registered Charity, it is required to comply with the financial reporting framework for financial statements which has been developed by the External Reporting Board (The XRB). The Society has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) (Tier 3) on the basis that it does not have a public accountability and its annual operating expenses do not exceed \$2,000,000 for the last two annual reporting periods.

Transactions in the financial and other statements are reported using the accrual basis and historical cost basis on the assumption that the Society will continue to operate in the foreseeable future.

These financial and other statements are presented in New Zealand dollars.

Revenue and Expenses

All income items are recorded in the Statement of Financial Performance in the year that it is earned. All revenue and all expenses from all sources are recorded in the Statement of Financial Performan

Cash and Bank Balances

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and hank balances (including short term deposits) with original maturities of 90 days or less.

Debtors

Debtors are recorded at estimated net realisable value.

Taxation

The Society is a charitable organisation registred with charities Services and provides services for the advancement of education within New Zealand. The Society haven exemption from Inland Revenue for Income Tax and Resident Withholding Tax. Any surplus of income over expenditure is not taxable.

Gifts to the Society are deductible by the donor as donations for tax purposes.

Property Plant and Equipmen

All property, plant and equilibrit are stated at cost less accumulated depreciation and impairment losses.

Goods and Services Tax (GST)

The Society is registered for GST.

The figures in the financial and other statements have been prepared on a GST exclusive basis with the exception of Accounts Payable and Accounts Receivable which are stated GST inclusive. Any GST refund due at balance date is shown as an asset and any GST owing by the Society at balance date is shown as a liability.

Grants Received in Advance

Grants received in advance comprise grants received from grantors where the conditions relating to the grants have not been fulfilled at balance date. The grants are recorded as revenue as the conditions are fulfilled.

Changes in Accounting Policies

There have been no changes in Accounting Policies. All policies have been applied on a basis consistent with those used in the last year.
