Privacy Policy

At the Golden Centre we take privacy seriously. By providing your personal information to us or using our services, you agree to this Privacy Policy. This Privacy Policy may change at any time and we will tell you about any changes by posting an updated policy on our website. Any change will apply from the date such policy is posted.

This Privacy Policy is subject to and should be read in conjunction with the Terms and Conditions for this website, our Disclaimers and any other terms and conditions you agree to when using or signing up to any of our services.

The types of personal information we may collect include:

- Name and contact details
- CCTV footage
- Correspondence with staff or retailers at the Golden Centre
- Cookies which track your visits to this website
- Your IP address and browser details

Please note that we collect information on website activity (such as the number of users who visit our website, the date and time of visits, the number of pages viewed, navigation patterns, what country and what systems users have used to access the site and, when entering our website from another website, the address of that website) through the use of 'cookies'. This information does not identify you personally but is useful for statistical purposes and the administration and improvement of our website.

We may use this information for the following reasons:

- Communicating with you on marketing, promotional or publicity matters
- As part of the investigation and analysis of incidents

- Contacting you regarding market research or surveys
- Improving our website and its content
- Any other use that you have consented to, or is directly related to the reasons for the information being provided

The Golden Centre uses reasonable endeavours to ensure that all personal information is securely protected against loss, unauthorised access and other misuse. We have a range of physical and technology measures in place to provide a robust security environment.
